## **Section 1: Instructions to Offerors**

### **1. Introduction:**

The National Association of ICT Companies (ATIC) is looking for a/several official suppliers, eligible and responsible to provide IT, office equipment for the endowment of 60 Digital Laboratories, initiative part of “Tekwill in every school program”, as described below in Section 1 (Instruction to Offerors).

The given procurement is managed under several Projects – implemented in the Republic of Moldova by ATIC, in partnership with UN Women, UNICEF, EU/Sweden: Building livelihood opportunities for local and Ukrainian women in Moldova - UN Women; Ensuring access to and participation in education of Ukrainian and Moldovan children through EDU Tech Labs - UNICEF Humanitarian Programme for Ukrainian and Moldovan children through EDU Tech Labs (Digital Labs), and The EU4Moldova: Startup City Cahul Project.

The required goods needed for the endowment of Digital Laboratories within 60 schools all over the country, are grouped into 11 LOTs, depending on the type of goods, and delivery requirements as follows:

**About ATIC:** THE MOLDOVAN ASSOCIATION OF ICT COMPANIES (“ATIC”) is the organization uniting over 94 companies, gathering over 9,000 employees. Being established in 2006, ATIC is the action leading association and the voice of the Moldovan ICT industry that promotes the development of the ICT sector in Republic of Moldova through viable partnerships between companies, similar organizations, government, state institutions and international organizations. The association was founded to represent the industry on different policy and ATIC has an extensive experience in implementing a variety of educational and entrepreneurial projects for children, youth and adults. One of the priorities includes supporting women in TECH, women empowerment and equal access to work opportunities.

**The EU4Moldova: Startup City Cahul Project** financed by EU through Sweden is in line with the Annual Action Programme 2019 in favor of the Republic of Moldova and its Action entitled, based on the Commission Decision ENI/2019/042-243.

The overall objective of the Action is to harness and strengthen the potential of the digital economy and enhance regional competitiveness, its business and its investment environment.

The specific objectives are:

- Foster partnerships for innovation and entrepreneurship between the private sector, public sector and educational institutions in the region of Cahul.
- Promote technology, problem solving and creative solutions in learning and make STEM topics (Science, Technology, Engineering and Mathematics) more attractive for women and men, girls and boys.
- Facilitate the emergence of start-ups in innovative sectors, build their capacity and investment readiness.

### **About UN Women Moldova for Ukrainian Refugees**

According to UN Women survey data, about 60% of the Ukrainian refugees were employed before fleeing Ukraine. Almost 40% of all refugees expressed willingness to start searching for a job and 3% have started working in Moldova. Having to provide for their families in the absence of men and with scarcity of childcare support options, refugee women’s care burden has/is expected to increase significantly in Moldova. Despite the available conditional and unconditional cash assistance which helps stabilize family’s livelihood conditions, improve health condition, education enrolment and wellbeing status for all members of the household, increase women’s resilience, and protect them and families from resorting to negative coping mechanisms i.e., drug use, school dropout etc.

Based on comprehensive mapping of existing programmes, capacities and needs of refugees and vulnerable categories of women in regions, UNWomen in partnership with ATIC and other partners, identified educational opportunities: recognizing/certifying skills, reskilling persons and labour (self)employment opportunities, as well as provide support to women refugees subsidizing childcare support, aimed at integration of refugees in Moldova.

### **About the UNICEF Humanitarian Programme for Ukrainian and Moldovan children through EDU Tech Labs (Digital Labs)**

As of early April, nearly 4.3 million refugees have crossed from Ukraine into Europe. About which 399,039 reached Moldova. Over 2 million refugees are estimated to be children, many separated or unaccompanied, about of which over 91,000 children, many with disabilities, were in institutional care in Ukraine. All are vulnerable and at risk of violence, trafficking, sexual and labour exploitation and abuse. Preventing family separation, ensuring immediate identification, and supporting reunification registration and safe spaces embedded in national child protection systems are urgent priorities.

Besides the key needs which include access to basic supplies, protection and care arrangements for unaccompanied and separated children (UASC), support to children with disabilities, health care services, including mental health and psychosocial support (MHPSS), and social protection, continued education is crucial.

The Digital Labs are envisaged as digital hubs where Ukrainian children connect to online learning platforms of the Ukrainian Ministry of Education or facilitate their inclusion into the Moldovan national education system. These labs will be also used as safe learning spaces for bridging Romanian language classes, catch-up classes, and joint STEM skills as well as digital learning sessions. These safe learning spaces will be open to both Moldovan and Ukrainian children and youth for interactive and informal education activities to support their social and emotional wellbeing and eventually aiming to strengthen and promote social cohesion.

### **2. Offer Deadline and Protocol:** Offers must be submitted no later than **15:00, local Chisinau time, on March 23, 2023**

Offers received after the specified time and date will be considered late and will NOT be evaluated by ATIC.

Offers must be submitted in one package in pdf format files, including the Forms A-F and other mandatory documents required by this solicitation documents – details in Section 3 - Technical Specifications. The Quotation for the requested goods shall follow the FORM F – Financial offer

All offers must be prepared in one of the 3 languages: English, Romanian or Russian.

**3. Questions:** Questions regarding the technical or administrative requirements of this RFQ may be submitted **no later than 12:00, local Chisinau time on March 21, 2023**, by email to [icorbu@ict.md](mailto:icorbu@ict.md), **cc:** [llivadari@ict.md](mailto:llivadari@ict.md) Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification—and the

responses thereto—that ATIC believes may be of interest to other offerors will be circulated to all RFQ recipients who have indicated an interest in bidding.

Only the written answers issued by ATIC will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of ATIC or any other entity should not be considered as an official response to any questions regarding this RFQ.

**4. Specifications:** Section 3 contains the technical specifications of the required items. All commodities offered in response to this RFQ must be new and unused (refurbished not accepted). In addition, all electrical commodities (if applicable), must operate on 240V, 50Hz

Please note that, unless otherwise indicated, stated brand names or models are for illustrative description only. An equivalent substitute, as determined by the specifications, is acceptable.

**5. Quotations:** Quotations in response to this RFQ must be set on a fixed-price, all-inclusive basis, including delivery and all other costs required at Section 3.

**Currency of Quotation & VAT:** Pricing must be presented in MDL (VAT 0% and exempt of customs taxes for donor funded goods, VAT inclusive for ATIC financed purchase).

**Quotation validity:** Offers must remain valid for no less than sixty (60) calendar days after the offer deadline. In exceptional circumstances, ATIC may request Companies to extend the validity of the Quotation beyond what has been initially indicated in this RFQ. The Proposal shall then confirm the extension in writing, without any modification whatsoever on the Quotation.

**Partial quotations: allowed per LOT**

In addition, offerors responding to this RFQ are requested to submit a copy of their official registration or business license.

- Quality Certificate (e.g., ISO, etc.) and/or other similar certificates, accreditations, awards, and citations received by the supplier, if any
- Certificates of quality and origin for the offered goods
- Environmental Compliance Certificates, Accreditations, and/or Markings/Labels, and other evidences of the Supplier's practices which contributes to the ecological sustainability and reduction of adverse environmental impact (e.g., use of non-toxic substances, recycled raw materials, energy efficient equipment, reduced carbon emission, etc.), either in its business practices or in the goods it manufactures
- Most recent Income Statement and Balance Sheet, for the last 3 years; ATIC has the right to reject any offer if submitted by a Supplier whom is not financially capable and/or had serious financial problems – low liquidity ration, (ATIC may check offeror's financial capacity of the Offeror and has the authority to seek references from concerned parties & banks on the Company's financial standing;
- 3 Reference Letters (proof of satisfactory performance) from Clients from the last (3) years;

**6. Delivery:** DAP Chisinau and other location points from Moldova: (please see Annex 1 – full list of delivery places) and Section 3 – Technical Specifications. As part of its response to this RFQ, each offeror is expected to provide an estimate (in calendar days) of the execution timeframe (after order receipt). The delivery estimate presented in an offer in response to this RFQ must be upheld in the performance of any resulting contract.

**Expected delivery:** Different delivery requirements depending on LOT. Please refer to Section 3 – Technical Specifications: LOTs 1A, 2A, 3A, 4A, 5A - **high priority delivery, up to 30 calendar days from contract issue date, but by March 31, 2023 preferable, for goods available in stock**; LOTs 1B, 2B, 3B, 4B, 5B - up to 45 calendar days from the confirmation of order/contract issue.

Without limiting any other rights or obligations of the parties hereunder, if the Supplier will be unable to deliver the goods by the delivery date(s) stipulated in the contract, the Supplier shall (a) immediately consult with ATIC to determine the most expeditious means for delivering the goods and (b) use an expedited means of delivery, at the Supplier's cost (unless the delay is due to Force Majeure), if reasonably so requested by ATIC.

## **7. Packing requirements**

Packing of goods should be performed as per standard procedures: it is the responsibility of the selected supplier to ensure that the delivered goods are intact/not tempered with. Damaged items will not be received and should be replaced with a new one of the same specifications.

**8. Customs clearance** of goods shall be done by the supplier.

**9. Source/Nationality/Manufacture:** Goods shall not be manufactured by entities included in EU or UN sanctions lists [www.sanctionsmap.eu](http://www.sanctionsmap.eu) ("EU Restrictive Measures") or [www.scsanctions.un.org/search/](http://www.scsanctions.un.org/search/) (United Nations Security Council Consolidated List Search)

**10. Warranty:** The warranty coverage must be valid on all goods/services/works after delivery/execution and acceptance of the services/works. For details please refer Section 3 – Technical Specifications and see the particular requirements for each lot. The full warranty shall include maintenance, troubleshooting and repair including provision of spare parts.

**11. Taxes and VAT:** Except the goods purchased from ATIC funds, the part of procurement, financed from Donor funds, does not permit the financing of any taxes, VAT, tariffs, duties, or other levies imposed by any laws in effect in Moldova. No such Cooperating Country taxes, VAT, charges, tariffs, duties or levies will be paid under an order resulting from this RFQ. In the event that any exempt charges are paid by the Contractor, they will not be reimbursed to the Contractor by ATIC. The Contractor shall immediately notify ATIC if any such taxes are assessed against the Contractor or its subcontractors/suppliers at any tier. The Contractor is responsible for payment of all applicable taxes, as prescribed under the applicable laws, associated with wages/salaries/compensation for services rendered by individuals employed by the Contractor and who are directed to work as required under this Contract. The Contractor is liable for payment of all applicable taxes associated with revenues (profit), and other such taxes, fees, or dues for which Contractor is normally responsible as a result of operating its business.

**12. Eligibility:** By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, bankrupt, or otherwise considered ineligible for an award.

**13. Evaluation and Award:** The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and meets or exceeds the minimum required technical specifications, and is judged to be the best value based on a **lowest-price, technically-acceptable basis**, business experience, the visual aspect of the work to be performed, similar objects in the past and short production and installation terms. The delivery period will also play an important role in case of the lots requiring the priority delivery.

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, ATIC reserves the right to conduct any of the following:

- ATIC may conduct negotiations with and/or request clarifications from any offeror prior to award.



- While preference will be given to offerors who can address the full technical requirements of this RFQ, **ATIC may issue a partial award or split the award** among various suppliers, if in the best interest of the Project.
- ATIC may cancel this RFQ at any time.

Please note that in submitting a response to this RFQ, the offeror understands that **Donors** are not party to this solicitation and the offeror agrees that any protest hereunder must be presented - in writing with full explanations - to ATIC for consideration, Donors will not consider protests regarding procurements carried out by implementing partners. ATIC, at its sole discretion, will make a final decision on the protest for this procurement.

**14. Terms and Conditions:** This is a Request for Quotations only. Issuance of this RFQ does not in any way obligate ATIC to make an award or pay for costs incurred by potential offerors in the preparation and submission of an offer.

Please note that the following terms and conditions will apply in case of any resulting award:

- a) Advance allowed for LOTS 1A, 2A, 3A, 4A, 5A. To be negotiated with the supplier. **Considerable advance payment (>= 50%) will be conditioned by the submission by the Contractor of a bank guarantee, which will be calculated as % of contract, by March 30, 2023.**
- b) Payments will be made in MDL, via wire transfer to the account specified in the Contractor's invoice. Payment of unpaid balances will be made upon completion and final acceptance of goods by ATIC. Any invoices for services rendered and deliverables submitted - but not accepted by ATIC - will not be paid until the Subcontractor makes sufficient revisions to the deliverables such that ATIC may approve the deliverables and thus the invoice.
- c) Payments will be made from separate accounts depending on Donor, thus separate invoices will be provided by the Supplier for goods financed from different sources (guidance from ATIC to be provided before invoicing);
- d) Payment will only be issued to the entity submitting the offer in response to this RFQ and identified in the resulting award; payment will not be issued to a third party.
- e) Any award resulting from this RFQ will be firm fixed price, in the form of a purchase order.
- f) *No goods or services may be supplied that are manufactured or assembled in, shipped from, transported through, or otherwise involving any of the countries/entities included in the EU and UN sanctions lists comprehensive mapping of existing programmes, capacities and needs of refugees and vulnerable categories of women in regions;*
- g) EU laws prohibit transactions with, and the provision of resources and support to, individuals and organizations associated with terrorism. The supplier under any award resulting from this RFQ must ensure compliance with these laws.
- h) Economic resources provided by the EU under this Project shall not be made available to, or for the benefit of, third parties - whether entities, individuals or groups of individuals - designated by the EU and/or UN Security Council as subject to restrictive measures in the lists provided at [www.sanctionsmap.eu](http://www.sanctionsmap.eu) ("EU Restrictive Measures") or [www.scsanctions.un.org/search/](http://www.scsanctions.un.org/search/) (United Nations Security Council Consolidated List Search)
